



We are shining the spotlight on two successful Lafayette attorneys who are men of value. Not only are they successful, but they also value the importance of their role in the legal profession and the importance of giving back to their communities.

Here are their stories...

## **Kirk Piccione**



Justice and philanthropy have been Kirk Piccione's mission. A proud graduate of LSU (1983) and Tulane Law School (1986), he has carved out a successful legal career while still finding time to serve the Acadiana community outside of the courthouse.

During a 15-year partnership with his father, Joseph James Piccione, he honed his skills at Piccione & Piccione. Following his father's retirement, Kirk's wife, Brenda, joined him in private practice, continuing the Piccione & Piccione legacy. Over his 33-year career, he has gained substantial experience in personal injury, business, and contract litigation. Kirk has successfully litigated everything from multi-million-dollar personal injury cases to capital murder cases.

Despite having had a diverse civil practice for many years, Kirk's recent focus has been on criminal defense, his true calling. When a crime victim asked how he could sleep at night defending the accused, he answered, "someone has to stand with the sinners and tax collectors." He acknowledges that his response is rooted in his strong Catholic faith. Despite the

challenges of being a criminal defense attorney, his unwavering commitment to ensuring that individuals are treated fairly in our justice system is a testament to his dedication and passion. Always championing the underdog, Kirk finds immense satisfaction in upholding the constitutional rights of the accused.

His service to professional legal organizations highlights Kirk's professional stature. A member of our esteemed national, state, and local bar associations, he is also a member of the Louisiana Association for Justice and the Louisiana Association of Criminal Defense Lawyers. His extensive pro bono work exemplifies his commitment to justice. He was pivotal in establishing the Lafayette Young Lawyers in 1990 and 1991, serving as its founding president for two one-year terms. He also served on the Board of Governor of the Louisiana Trial Lawyers Association (1989-91) and was a Board Member of the Louisiana Association for Justice. On three occasions, the Louisiana Supreme Court named him Court Appointed Administrator, whose job was to administer the practices of disbarred or suspended attorneys, ensuring their clients were not left hanging. At the request of the Lafayette Parish Sheriff's Office, Kirk has volunteered over the past decade as a trainer for the Acadiana Law Enforcement Training Academy, teaching cadets courtroom responsibilities and practices. Kirk also served on the 15th Judicial District Court District Defender Selection Committee. He has given numerous Continuing Legal Education presentations. Kirk has also presented on criminal justice topics to high school, paralegal, and college students.

Kirk's dedication to the legal profession spills over into serving the legal community at large, especially causes that benefit children and youth. As a Past President of the Kiwanis Club of Lafayette, he has twice held the prestigious position of Lieutenant Governor of the tri-state District. Over his 35-year volunteer history, he has humbly given of his time, talent, and treasure to causes such as Operation Magi, the Kiwanis Football Jamboree as the play-by-play announcer, and various children's projects and fundraisers reflecting his unwavering dedication to community service. Kirk has been recognized and honored for his service in Kiwanis. He is the recipient of the Kiwanian of the Year award, the Life Member Award, and the Hickson Fellow Award. He has also served as an assistant scout master for the Cub Scouts and worked diligently as a volunteer with BSA Troop 271 for several years. He has coached SLYSI football, girls volleyball, and girls basketball teams. He was a roadie for the St. Thomas Moore High School Band for four years. He regularly volunteered at his four children's schools for twenty-five years in academic, fundraising, athletic, art, and music activities.

The arts, the local culture, and his faith community are beneficiaries of Kirks' time, talent, and treasure. He served on the executive committee of the Acadiana Symphony Association, as a board member of the Acadiana Center for the Arts, where he was also the treasurer, and as a board member of the City-Parish Parks and Recreation Commission. He has also volunteered at Holy Cross Catholic Church, the Cathedral of St. John the Evangelist, Festival Internationale, Gulf Brew, I-10 Bowl All-Star Game, and other local events. Kirk organizes and hosts reunion activities for the Cathedral Carmel Class of 1980, helps to produce local theater productions through Stage Backers and serves as campaign treasurer for various political candidates.

Grounded by his strong faith, led by compassion for family and humanity, driven by his deep-seated passion for criminal justice, and inspired by his love of the local culture and the arts, Kirk Piccione is a Lafayette attorney whose philanthropic service extends far beyond the courtroom. His faith and values guide his work, ensuring that he always acts with integrity and compassion, both in his legal practice and in his community service. His dedication to justice and his love for his community are not just professional obligations but deeply held personal beliefs that he lives out every day.

## Patrick (Pat) S. Ottinger



As an Acadiana lawyer who serves, Patrick (Pat) S. Ottinger's giving spirit is channeled through his legal practice, academic pursuits, mentorship, and charitable contributions. He humorously jokes that "when you go to a program, [and] it says, 'anonymous,' that's usually me." A graduate of Lafayette High School, Pat was born in Lake Charles; he was raised in Lafayette due to his father relocating the family for work in the oil and gas industry. Following in his father's footsteps, he has carved his niche in the oil and gas industry. While Pat does not care to be in the limelight and usually opts out of participating in civic clubs and organizations, his giving spirit infiltrates his everyday life, making him a beacon of service in the Acadiana area's legal community.

Pat's path to law was not a conventional one. After completing his undergraduate studies at the former University of Southwestern Louisiana (now known as the University of Louisiana at Lafayette), he found

himself in a lackluster job market in the Lafayette area. It was during this time that he and a few friends, in a bold move, decided to try their luck at law school. While his friends did not find their calling in law, Pat did. Graduating from the Paul M. Hebert Law Center, Louisiana State University, led to a five-decade-long legal career, a testament to Pat's passion and dedication. Reflecting on his 50 years as an attorney, Pat expresses pride in prioritizing his clients, maintaining a professional and ethical practice, and serving as the president of the Lafayette Parish Bar Association and later as president of the Louisiana State Bar Association (1998-99). For his distinguished work and service, he has received a multitude of awards and recognition, such as the Louisiana State Bar Association Friend of Pro Bono Award and the Distinguished Achievement Honoree, and the Lafayette Bar Association Hall of Fame. Receiving the Louisiana Bar Foundation's 2018 Curtis R. Boisfontaine Trial Advocacy Award is an attestation of Pat's "long-standing devotion to and excellence in trial practice" and "upholding the standards of ethics and consideration for the courts, litigants, and all counsel." Further, he treasures the opportunity to interact with fellow colleagues, professors, and judges in his practice area and is humbled to be among the few individuals who have held such prestigious positions and honors.

Pat's love for the law extends beyond his practice; he remains passionately dedicated to the world of academia. Despite the challenge of commuting from Lafavette to Baton Rouge, he has been sharing his passion with students as an adjunct professor at LSU Law School since 1996. At the law school, he also serves as a reporter for the Mineral Law Committee of the Louisiana State Law Institute and is involved with the John P. Laborde Energy Law Center. He previously served as Chair of the Advisory Council of the Mineral Law Institute. Licensed in Louisiana and Texas, he shares his oil and gas expertise with his colleagues in Texas and throughout Louisiana with CLE presentations. A testament to his commitment

to knowledge dissemination, Pat has published a comprehensive treatise on mineral leases entitled Louisiana Mineral Leases: A Treatise and has authored multiple academic and substantive materials on oil and gas law. His diverse academic portfolio reflects his dedication to professional development within the legal community.

Pat's altruism extends to the mentorship of new lawyers, a testament to his empathy and support for the next generation of attorneys. He proudly shares his participation in the State Bar's Transition Into Practice "TIP" Program, a mentorship program that guides new lawyers through their transition into practice, particularly during the challenges brought about by the COVID-19 pandemic. He notes that participation was mandatory for new lawyers but not required for senior lawyers, which he found regrettable. Despite this, he engaged in the program and found it highly rewarding. Encouraging attorneys to participate, he underscores the importance of supporting and guiding new lawyers as they navigate the complexities of the legal profession. Pat expresses concern about the decline in civility in professional relationships over the years. He recalls a time when the legal practice was more collegial, and agreements were often made verbally without requiring written confirmation. This year, Pat shifted his role from an oil and gas attorney to Lafayette City-Parish Attorney, marking his return to a position he had previously held 20 years ago. Now, he takes proactive steps as a City-Parish Attorney, implementing measures to instill professionalism and community service among legal practitioners. In this role, he has implemented measures aligned with his concerns by insisting that newly hired Assistant City-Parish Attorneys re-sign the Oath of Professionalism. Additionally, he strongly encourages participation in the Lafayette Volunteer Lawyers Program and/or donating the equivalent of one hour of their monthly billing rate to the Share the Light Program, which assists individuals in paying their electrical bills. While he does not strictly enforce these requirements, he firmly advocates for their adoption, trusting that attorneys will fulfill these commitments voluntarily. His commitment to highlighting community service and professional conduct in the legal profession is a personal passion Pat recognizes as necessary in fostering a sense of responsibility and service among lawyers.

Privately, his philanthropy knows no bounds, recognizing the importance of contributing to essential efforts within the community. He supports causes dear to his heart, from poverty relief to Alzheimer's research to local cancer services. Pat has supported the Share the Light program for over 20 years. Seeing the horror of hunger, Pat does his part to combat it by supporting food bank initiatives through Second Harvest and our local United Way. Driven by his mother's passing due to Alzheimer's disease, Pat donates 100% of the royalties from the sale of his comprehensive treatise to the Alzheimer's Association. Additionally, he supports Miles Perret Cancer Services, inspired by his wife's experience with the organization five years ago. Regarding advice for new lawyers entering the oil and gas field or law students aspiring to specialize in this legal realm, Pat emphasizes the importance of finding one's niche. He encourages new lawyers to focus on one or two crucial aspects within the broad scope of their chosen area of the law and dedicate themselves to mastering them. However, he stresses the broader principle of pursuing what one enjoys. While he acknowledges the practicalities young lawyers may face, such as financial obligations and family responsibilities, he ultimately advises following one's passion for the law and striving to advance the legal profession. He emphasizes the significance of upholding the highest ethical and moral standards, believing that success will naturally follow.


